**Important Information Regarding Restrictions on Transfers from your Share Accounts.** Under government regulations that apply to your share accounts, you may not make more than six transfers and withdrawals, or a combination of such transfers and withdrawals, from your share account, per calendar month to another credit union account of yours or to a third party by means of a preauthorized or automatic transfer (including automation overdraft protection transfers), or a telephonic agreement, order, or instruction (including transfers by way of an audio response or home banking system). This includes transfers made by check, draft, debit card, or similar order made by you and payable to third parties. Withdrawals by mail, messenger, ATM, or in person, and transfers to make payments on your loans are generally not included in this limitation. However, transfers from your share accounts to make payments on loans that your family members may have with us are counted against this transaction limitation. If you exceed the number of transfers permitted, your account may be subject to a fee or be closed.
